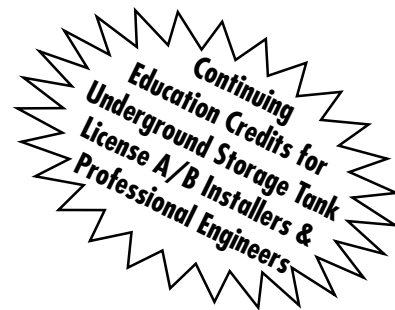


# 7th Annual UST Management & Compliance Assistance Seminar December 12, 2006

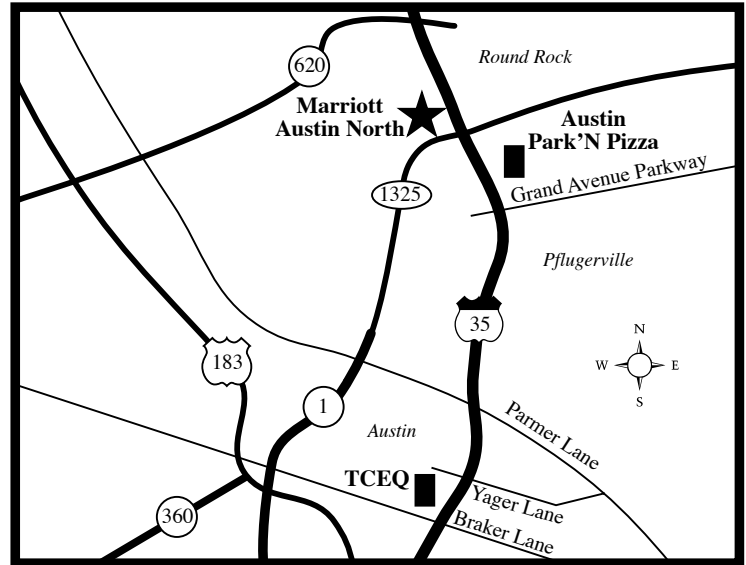
